Newburyport Education Foundation continues its mission to enable regular replacement and upgrade of technology resources, as well as building toward meeting state technology benchmarks for all schools. Five projects fall into this category in 2013: 1) New computers for Brown school teachers gave them valuable technology upgrades. And new tablets allowed Brown School teachers and students to pilot several early learning apps designed to boost achievement. 2) To avoid lost access to computer labs during the Molin/Nock renovation, two netbook carts were purchased to prevent interruption in technology-based learning in grades 4-8. 3) iPad technology maximized the newly reinstated language program at the Nock middle school. 4) Increased server capacity was completed in 2013 at the high school. 5) The state-of-the-art Robotics lab in the Middle school was completed in 2013.

Through the continuation of our literacy program we continued to build classroom libraries and added nonfiction reading materials in grades K-8.

In 2013 motivated businesses and teachers came together to create some amazing learning experiences for our students funded by 24 partnership grants, the Technology club at the High School, the Gulf of Maine institute program at the High School and Middle School, and the bookbag program at the elementary school.
