WE COMPLETED PHASE 3 OF THE RENOVATION OF THE HIGH SCHOOL AUDITORIUM BY REPLACING THE STATE RIGGING AND INSTALLING ADDITIONAL LED LIGHTING IN 2017. THE PURPOSE OF THE PROJECT WAS TO UPDATE THE INFRASTRUCTURE OF THE PRODUCTION FACILITY THAT WILL PROVIDE STUDENTS AT THE SCHOOL AND THE COMMUNITY AN AUDITORIUM THAT IS UP TO CODE AND HAS MODERN CAPABILITIES TO SUPPORT ARTS, MEETINGS, AND CITY AND OTHER CULTURAL EVENTS. SPECIFICALLY, THE PROJECT UPDATED THE KEY SYSTEMS THAT SERVE THE AUDITORIUM WHICH HAVE DETERIORATED TO THE POINT THAT THEY WERE NOT USABLE OR HAVE VERY LIMITED CAPABILITIES.

THE STEM INITIATIVE ALSO WAS IMPLEMENTED IN THE NOCK AND MOLIN SCHOOLS VIA GRANTS FOR EQUIPMENT INCLUDING 3D PRINTERS AND ROBOTS. THIS PROGRAM ALLOWS OUR STUDENTS TO ENHANCE THEIR EDUCATION IN SCIENCE, TECHNOLOGY, ENGINEERING AND MATH.
